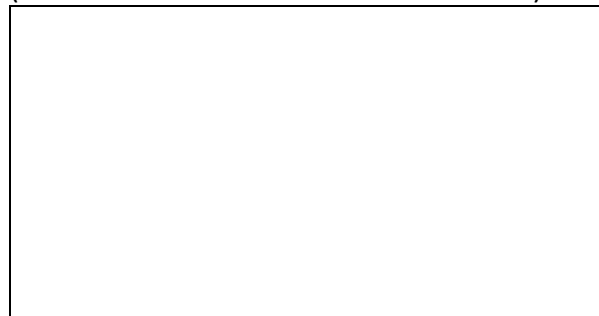
Performer represent and warrant that Performer is at least 18 years of age and have the full legal capacity to execute this release, with a date of birth, listed in the "Model Information" section of this document.
